


### GENERAL MATERIALS LEGEND FOR SRJC PROJECT

#### CONSTRUCTION NOTES:

1. SAWCUT OF PAVEMENT SHOULD BE IN A NATURAL SHAPE AND BACKFILLED WITH 1" MINIMUM CRUSHED ROCK.
2. STEEL HEADER TO BE INSTALLED PER MANUFACTURERS INSTRUCTION AFTER SAWCUT EDGE TO SMOOTH CURVE ALONG DRIVEWAY.
3. CONCRETE FROM SAWCUTS CAN BE USED AT BASE OF MOUNDS FOR DRAINAGE.
4. FLAGSTONE PAVERS SHOULD BE SET ON 2" SAND AND AT LEAST 2" THICK. LEAVE FULL SIZE AND CUT ONLY TO SHAPE TO FIT BEST.
5. MOUNDS SHOULD BE CREATED WITH LEAN TOP SOIL.
6. TREE ROOTS SHOULD BE PROTECTED - IF DIGGING FOR PLANTING RESULTS IN DAMAGE TO ROOTS MOUND SOIL RATHER THAN DIG.
7. PLANT MATERIALS SHOULD BE SELECTED FROM SMALLEST SIZE AVAILABLE TO INSURE BEST HEALTH.
8. ROCK MULCH TO 3" INSTEAD OF ARBOR MULCH.
